

Data Privacy Statement

1 Information about the collection of personal data

Below we would like to inform you about the collection of personal data when using our website. Personal data are all data that are personally identifiable to you, e.g. name, address, e-mail addresses, user behaviour.

The controller pursuant to Art. 4 para. 7 of the EU General Data Protection Regulation (GDPR) is

When you contact us, the data you provide (your e-mail address, if applicable your name and your telephone number) will be stored by us in order to answer your questions. We erase the data arising in this context after the storage is no longer necessary, or limit the processing if statutory retention obligations exist.

If we use contracted service providers for individual functions of our offer or would like to use your data for advertising purposes, we will inform you in detail about the respective processes below. In doing so, we comply with the legal requirements for the storage period.

2 Your rights

You have the following rights towards us with regards to personal data concerning you:

- Right to information and access,
- Right to rectification or erasure,
- Right to restriction of processing,
- Right of object to the processing,
- Right to data portability.

You also have the right to lodge a complaint with a data protection supervisory authority about our processing of your personal data.

3 Collection of personal data when visiting our website

When using the website for information purposes only, i.e. if you do not register or otherwise provide us with information, we only collect the personal data that your browser transmits to our server. If you wish to view our website, we collect the following data, which are technically necessary for us to display our website and to guarantee stability and security (legal basis is Art. 6 para. 1 s. 1 lit. f GDPR):

- IP address
- Date and time of the request
- Time zone difference to Greenwich Mean Time (GMT)
- Content of the request (specific page)
- Access status/HTTP status code
- The amount of data transferred in each case
- Website from which the request comes
- Browser
- Operating system and its interface
- Language and version of the browser software.

4 Other functions and offers on our website

Personal data of the website's users and our registered customers will only be disclosed to third parties if this is necessary for the purpose of contract processing (such as with regard to payment service providers) or if express consent has been given. However, KMS Gesenkschmiede GmbH may also use service providers for the collection, processing and use of personal data (which are not third parties as defined by data protection law). As processors, they are contractually obliged to process data only for the purposes specified by KMS Gesenkschmiede GmbH (and not for their own, other purposes) and subject to the instructions given by KMS Gesenkschmiede GmbH. KMS Gesenkschmiede GmbH has concluded corresponding so-called order processing contracts with all processors to ensure this. Service providers (processors) receive from KMS Gesenkschmiede GmbH only those personal data which they require for the specific activity. Service providers can also be commissioned to provide data centre services (within the EU), to evaluate the user-friendliness of our website or to provide technical support. With a few exceptions, all these service providers are based in the EU or the European Economic Area. If service providers are exceptionally based outside the EU or the European Economic Area, KMS Gesenkschmiede GmbH has implemented measures to ensure that all of these persons and organisations respect your privacy and protect personal data only in accordance with the requirements of the applicable data protection law.

In this respect, it is also important for us to emphasise that service providers may not disclose your data to subcontracted data processors without the consent of KMS Gesenkschmiede GmbH. Personal data will also only be transferred to authorities or other state institutions if this is permitted under data protection law and is required by mandatory national legislation.

5 Right to object to processing of your data

If you have given your consent to the processing of your data, you can revoke this at any time. Such a revocation affects the permissibility of the processing of your personal data after you have given it to us.

To the extent that we base the processing of your personal data on the weighing of interests, you may object to the processing. This is the case if the processing is in particular not necessary for the fulfilment of a contract with you. We describe this individually in the following description of the functions. When exercising such objection, we ask you to explain the reasons why we should not process your personal

data as we have done. In the event of your justified objection, we will examine the situation and either stop or adapt the data processing or point out to you our compelling reasons worthy of protection, on the basis of which we will continue the processing.

Of course, you can object to the processing of your personal data for purposes of advertising and data analysis at any time. You can inform us about your advertising contradiction using the following contact data:
